ELIGIBILITY: 1) Candidates must be Indian Citizen.

2) **P/T – EE:** Passed 10th Std. / SSC examination and 2 Year ITI after 10th Std.

OR

Passed 10th Standard / SSC examination and Minimum of Two years full time work experience in a registered firm / Company / Industry / Educational and Government / Autonomous Organizations in the relevant field in which admission is sought.

3) **Age:** There is no age limit.

APPLICATION: The prescribed ***Application Form is to be downloaded from the Council's website www.webscte.org from 28.07.2017*** (Print out of the Application Form to be taken on both sides of a A4 size page).

SUBMISSION OF FILLED-IN APPLICATION FORM: The Application Form, duly filled-in, should be submitted in person or through messenger to **Technique Polytechnic Institute**, Panchrokhi, P.O. Sugandha, Dist.-Hooghly, PIN-712102 on any working day [except Sundays and gazetted holidays] between 11.00 a.m. and 4.00 p.m. within **07.08.2017** along with cash of **Rs.500/- (For Kanyashree candidates, Rs.250/-)** only.

No document is to be enclosed with the application form. But, photocopy of the Identity Card issued by the present employer (if applicable) is to be submitted along with the filled in Application form by the applicants of the Part Time in Electrical Engineering course. Also, photocopy of 'Kanyashree document' is to be attached with the application by the Kanyashree candidates. Following **original** testimonials will have to be produced by the merit listed candidates at the time of counselling and also at the time of admission for verification.

- (i) Mark sheets and Admit Cards of qualifying examinations.
- (ii) Admit card of Madhyamik
- (iii) Medical Certificates (2 nos.) obtained from Registered Medical Practitioner or Medical Officer of a Government Hospital in the prescribed form. The certificate must possess registration number and seal of the medical practitioner /officer.
- (iv) Kanyashree documents.
- (v) Identity Card and experience certificate related to Employment (if applicable)
- (vi) NOC from the employer (in case of a candidate who is currently employed)

An applicant should ensure that he/she satisfies the requirements relating to Educational Qualifications, Professional experiences etc. before submission of the filled-in application form. The application form will be automatically rejected if a candidate does not fulfil these requirements. Any candidate, found not in full conformity with his/her submitted information at the time of verification of original testimonials, will not be allowed admission even though he/she is merit listed. Application Form will have to be filled-up properly and completely in all respect. *No request for subsequent change in information, submitted by the candidate in the filled-in application form, will be entertained under any circumstance. The Council is not liable for refusal of admission to a candidate by the Institute even after being merit listed for wrong submission of information by the candidate.*

METHOD OF SELECTION: For above mentioned course, selection will be made on the basis of marks obtained in aggregate by the eligible applicants in qualifying examinations.

PUBLICATION OF MERIT LISTS:

The Council will publish Merit List which will be displayed **in the Notice Board of Technique Polytechnic Institute**, but shall not communicate the result to any individual applicant. The merit list will also be available in the council's website www.webscte.org. There is no provision for post-publication scrutiny or review. *No Rank Card will be issued by the Council to the merit listed candidates.*

ADMISSION: Admission of candidates to the institution mentioned above will be made from the merit listed candidates through Institute level counselling. Detailed information regarding the programme of counselling and other related matters shall be available in the Notice Board of the Institute mentioned above after the publication of the merit list and also in the website of the Council at www.webscte.org.

LEGAL JURISDICTION

All disputes pertaining to admission of students under the above mentioned courses shall fall within the jurisdiction of Kolkata only.
